## FACTS WHAT DOES ELLAFI FEDERAL CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<ul> <li>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</li> <li>Social Security number and account balances</li> <li>Account transactions and checking account information</li> <li>Credit history and credit scores</li> <li>Income and retirement assets</li> <li>When you are <i>no longer</i> our member, we continue to share your information as described in this notice.</li> </ul>
How?	All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their

How? business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons Ellafi Federal Credit Union chooses to share; and whether you can limit this sharing.

How does Ellafi Federal Credit Union protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured fi les and buildings.
How does Ellafi Federal Credit Union collect my personal information?	<ul> <li>We collect your personal information, for example, when you</li> <li>Open an account or use your credit or debit card</li> <li>Apply for financing or give us your wage statements</li> <li>Provide employment information</li> </ul>
Why can't I limit all sharing?	<ul> <li>Federal law gives you the right to limit:</li> <li>Sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>Affiliates from using your information to market to you</li> <li>Sharing for nonaffiliates to market to you</li> <li>State laws and individual companies may give you additional rights to limit sharing.</li> </ul>
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on the account you have with us.

Nonaffiliates	<ul> <li>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</li> <li>Ellafi Federal Credit Union does not share with our non-affiliates so they can market to you</li> </ul>
Joint marketing	<ul> <li>A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Our marketing partners include:</li> <li>Credit card companies</li> <li>Insurance companies</li> <li>Other financial service providers</li> </ul>
